



III. New ways of "doing politics"

"It is because it was done locally and, in very small cities, you have several people doing things: they do the protests for a forest protection, about the abortion ban, the same people are doing the protests outside the Courthouse for judiciary independence. This is the strength of the local coalitions. This is much harder in the big cities because there are so many divisions and everybody requires so much time to discuss the programs, the words, the narratives... 
