


Media

- **Securitisation** frames in the news coverage of the '**migration crisis**' (Sedlákova, 2017; Tamchynová, 2017; Tkaczyk, 2015; Tkaczyk et al 2015)
- Before 2015 →
 - most coverage about Islam in traditional media tends to focus on **foreign issues** and **conflicts** (Křížková, 2006; Korečková & Lužný in Topinka, 2016);
 - emphasizes '**pathological**' aspects (Vesecký, 2006; Sedláčková, 2011; Čermáková, Janků, Kliment & Linhartová in Topinka, 2016, p. 105)

Public debate

- ‘**Anyone**’ became **allowed into** the (post-factual) public debate about ‘Islam’, (Ostřanský, 2020, 2017, pp. 17–23) and its ‘imaginary Muslims’ (*Ibid*, 48; Černý, 2016), including **popular figures** (Rosůlek, 2018)


Martin Konvička, leader of the movement ‘We Do Not Want Islam in the Czech Republic’ appeared often on television in early 2015

How big of a threat do the following pose for our country...


Showing percentage of answers 7-9, on a scale 1-9
where 1 = no threat, 9 = a very big threat.




STEM, Trendy 2011/3, 2015/9, 2018/4

- Marked spikes on perceived ‘threat to Czechia’s security’ of **terrorist groups/individuals, wars, refugees, radical religious movements (CVVM) and Islamic fundamentalism (STEM)**

Graf 1 – Problémy ČR a Evropské unie, názory Čechů, možnost více odpovědí, vývoj 2014–2018




Respondents who select 'terrorism' as one of the two biggest issues facing the EU





Public Opinion → attitudes that predate 2015

- Negative attitudes towards **Arabs** and other **ethnic/national groups** from **Muslim-majority** countries in surveys since, at least, early 2000s
- Fear of Islam and opposition to mosques (Břešťan, 2006)
- Reticence to accept Muslim migrants as long-term residents (Topinka 2016, Chapter 15) – but acceptance grows if proof of clean criminal record (Median, 2018)

Politics (2015-)

- 2014/2015 → **charismatic** leaders revive Czech **far-right** (Slačálek, 2019) with an issue they own
- Political **mainstreaming** (Hesová, 2016; Stulík & Krčál, 2019), interpreting **statistics** (Prokop, 2019)
- **2017 general elections** → playing the 'Muslim card' (Krčál & Naxera, 2018)
