Pillarization of Society

“Pillarization is the vertical segregation of civil society into distinct compartments with limited interaction across a dividing boundary (religious, ethnic, political). This creates the potential for social conflicts, contentious mobilization and political instability” (Ekiert, 2019)

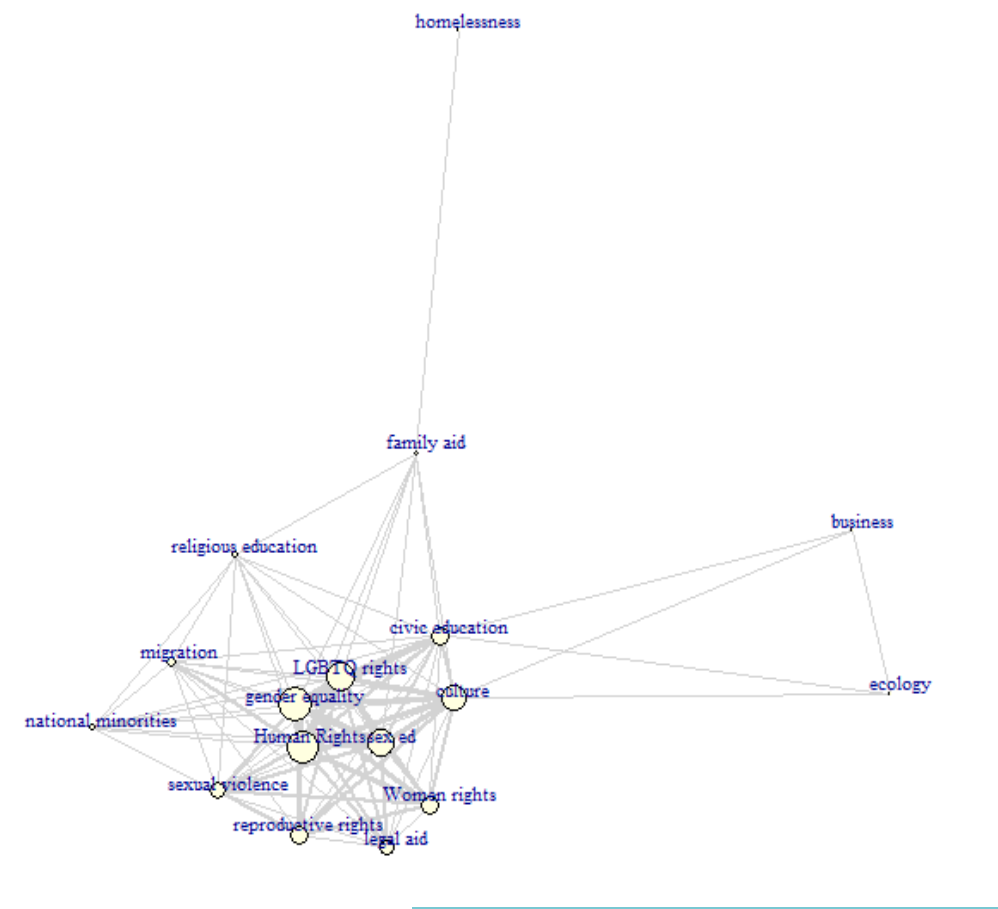
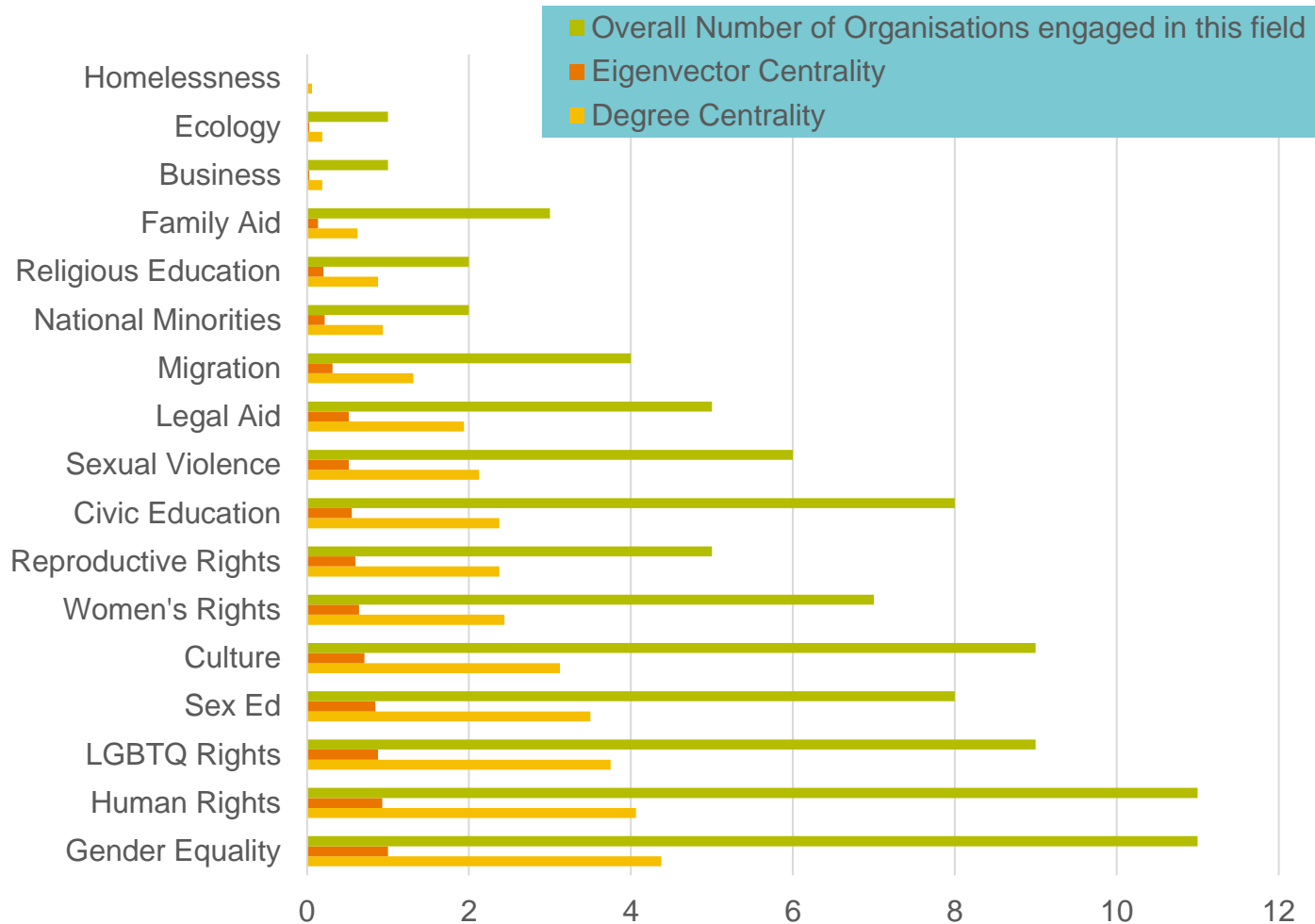

Centrality Scores- Fields of Engagement and overall number of organisations

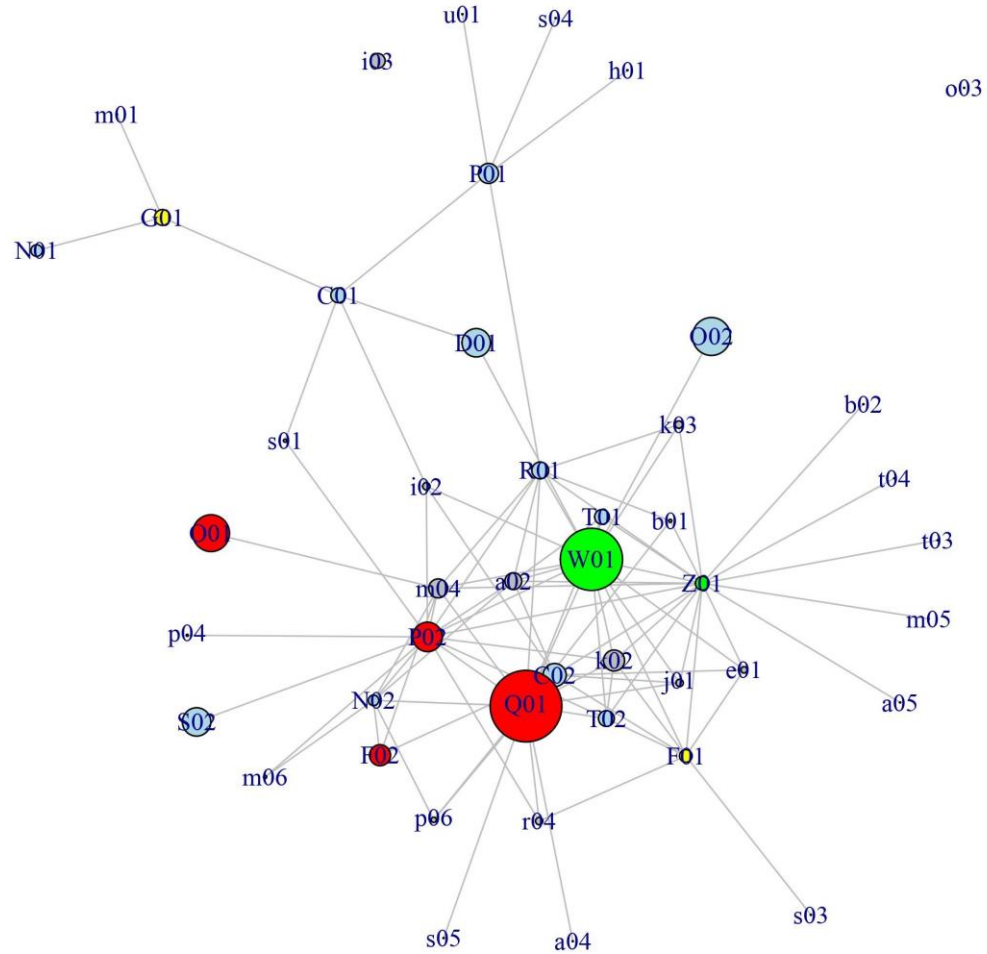

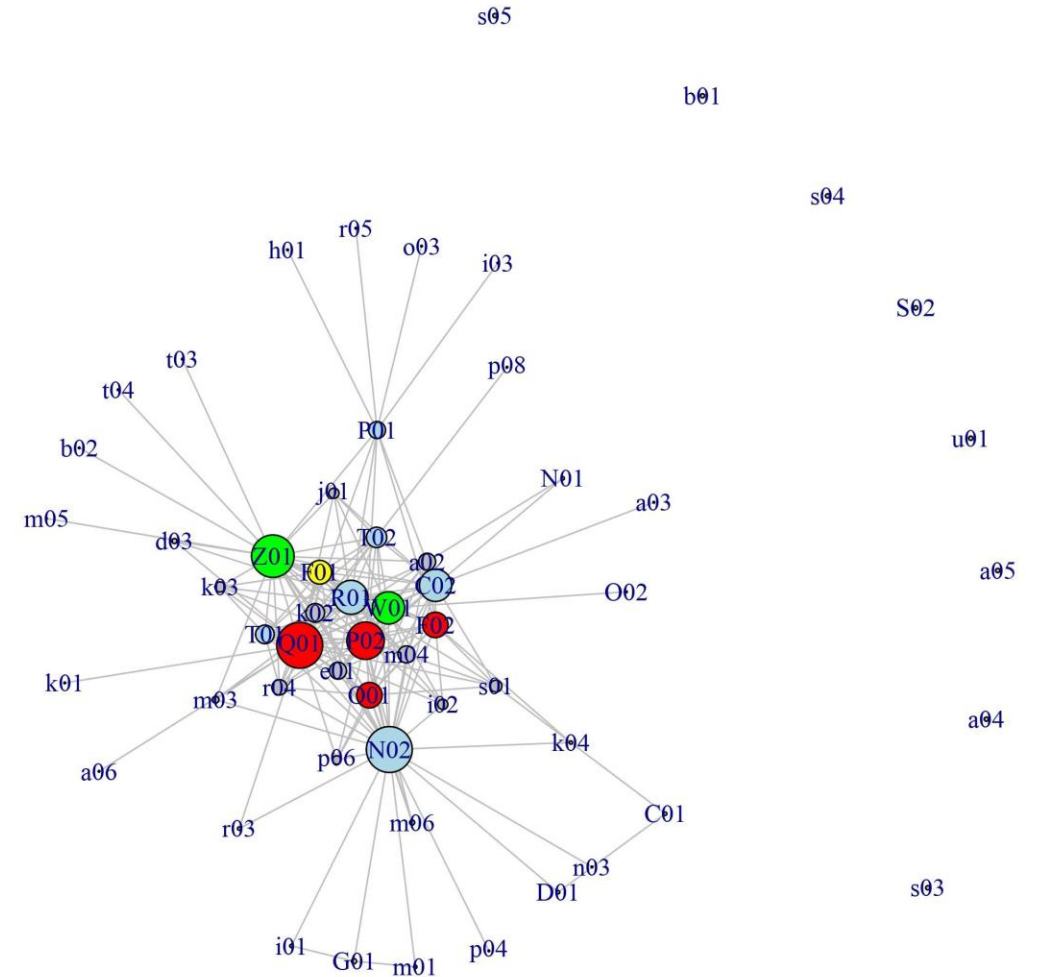

Network of Cooperation Ties



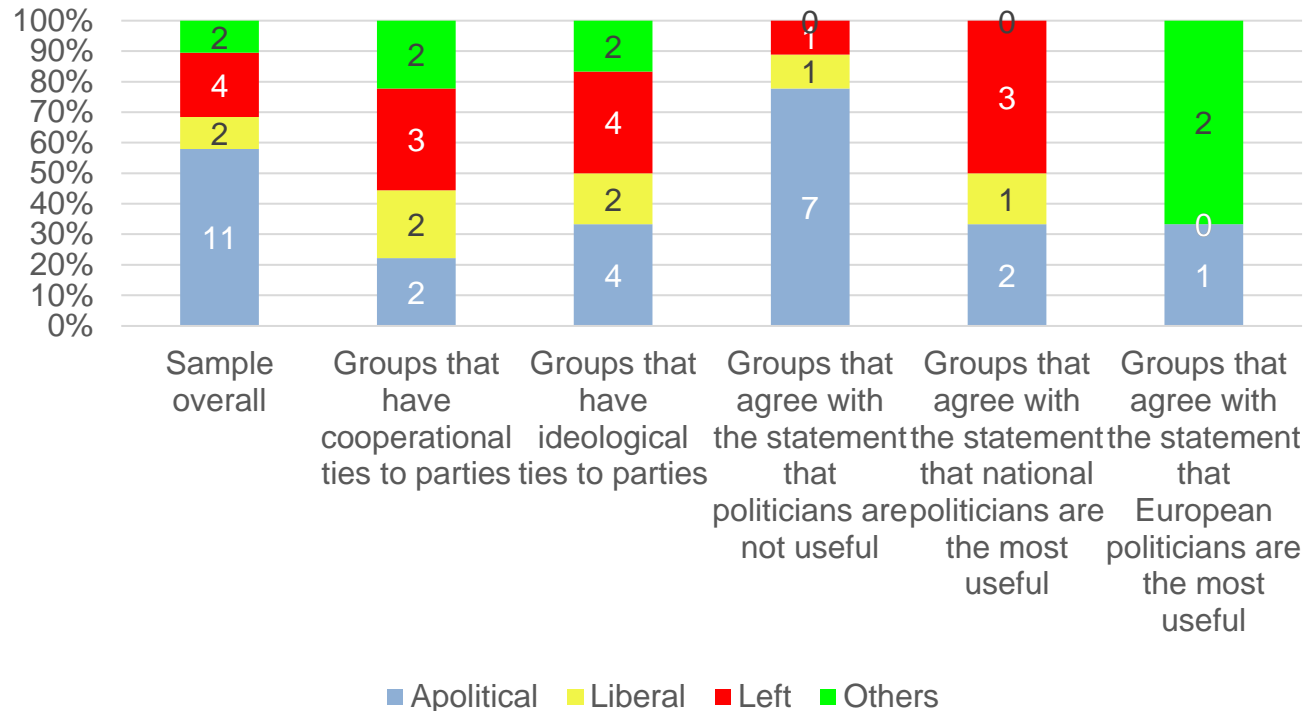

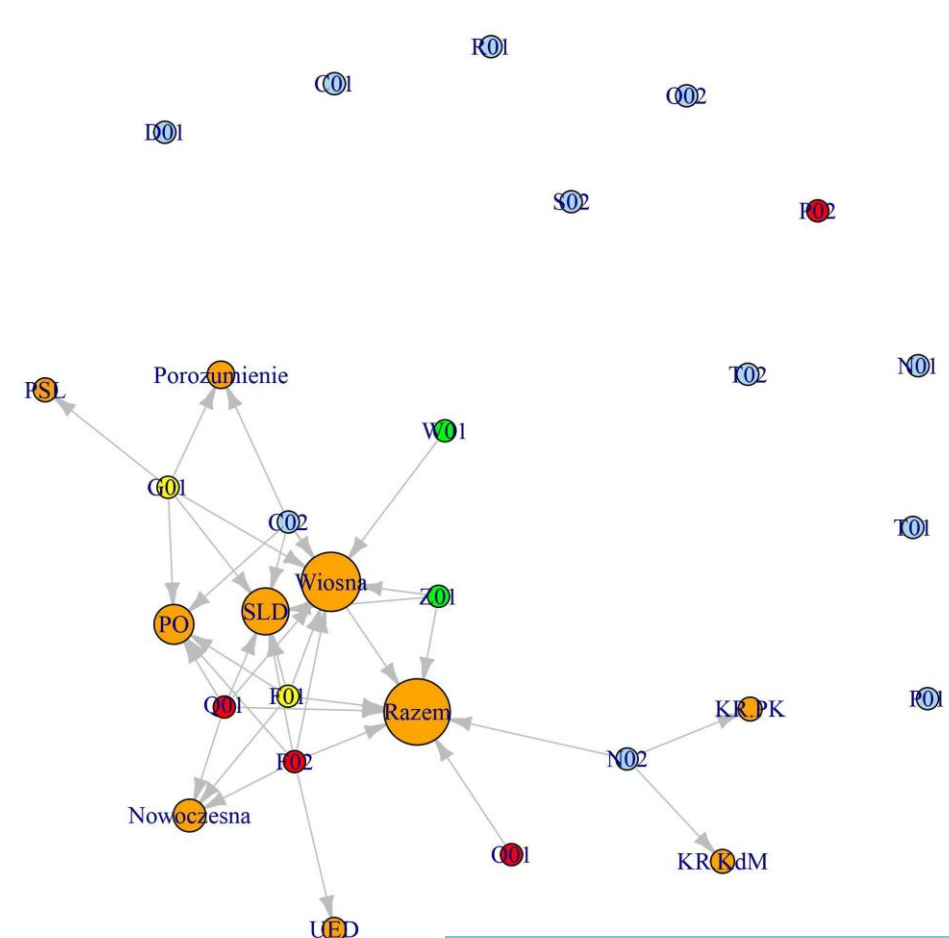

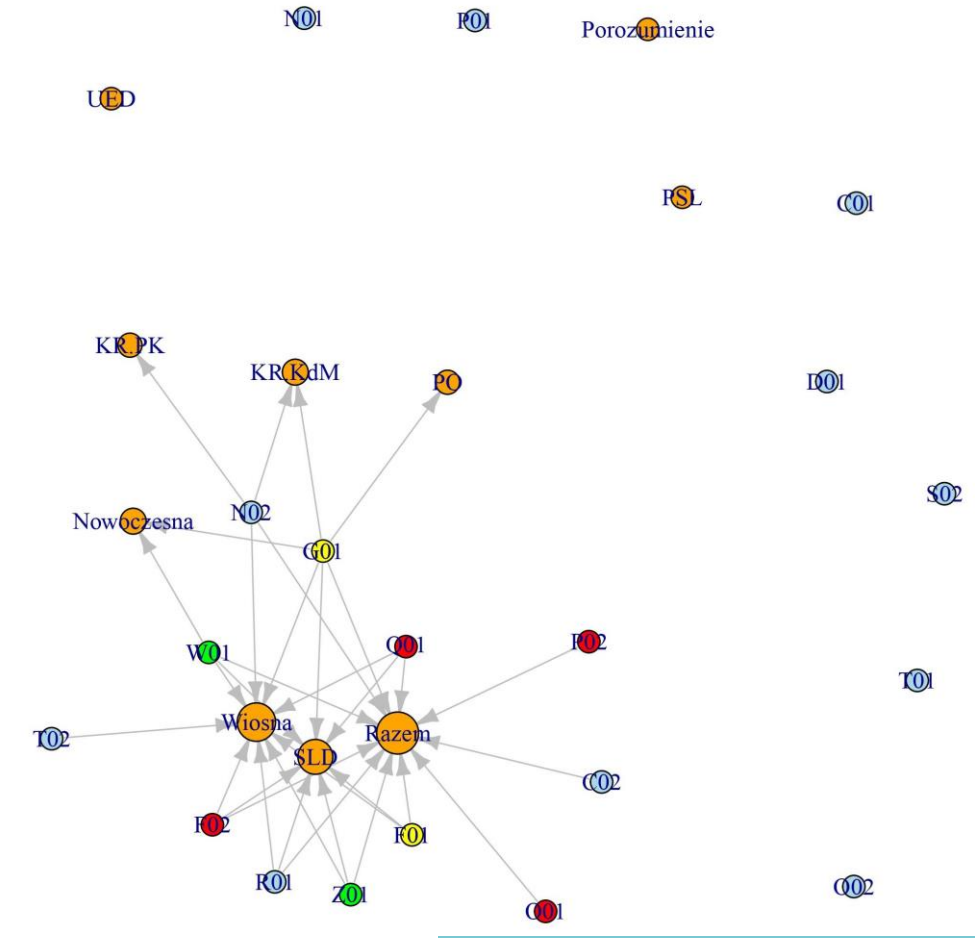

Summary

- This paper took the liberal pillar as a starting point to explore pillarization in civil society mobilised around gender in the city of Krakow
- Division between liberal and illiberal pillar in civil society mobilised around gender
- Within the liberal pillar, civil society actors' position in the network is influenced by their stance “political vs. apolitical”; this effect is much more relevant in relations to political parties
- Need to explore the role of apolitical civil society actors
